Candidate Statements

Candidates may submit a statement of no more than 200 words and a passport sized photograph to be included with ballot material. The material may include an indication of preference provided all candidates are shown in the order they appear on the ballot paper and there is a preference allocated to each candidate. Statements should be provided in MS Word format and may be emailed to IEBnominations@aec.gov.au.

Only statements which comply with the Rules and are received by the Returning Officer by 12:00pm (Australian Eastern Standard Time (AEST)) on 13/09/2024 can be accepted.

Scrutineer Appointment

Scrutineers must be a financial member of the union. The appointment of scrutineers closes 10:00am Australian Eastern Daylight Time (AEDT) on 28/10/2024.
